



# Vicki Preston, President & CEO

Vicki grew up in Northeast Ohio, near the shores of Lake Erie. Growing up surrounded by plentiful natural beauty instilled in her a passion for protecting the environment. Vicki earned her B.S from The Ohio State University, with a double major in Environmental Science and Environmental Education & Communications.

She began her career working for the Soil and Water Conservation District where she managed many natural resource projects, performed construction site inspections for erosion and sediment control measures, ran the stream quality monitoring program, managed the GIS storm water outfall database for the County, and served on the Grand River Partnership steering committee. The partnerships made here lead her to become the Watershed & Land Protection Coordinator with Grand River Partners – a successful land trust working within the Grand River Watershed, a State designated Wild and Scenic River in northeast Ohio. There she wrote a comprehensive watershed conservation plan for the 92 mile long Grand River, which was approved and endorsed by the Environmental Protection Agency and the Ohio Department of Natural Resources. The implementation of this plan led to thousands of acres of critical wildlife and riparian habitat land protection.

Before her love for the west brought her out to Arizona in the fall of 2010, Vicki served on the state board of the Coastal and Estuarine Land Conservation Program, which was responsible for awarding millions of dollars in competitive grants for coastal lands conservation.

She is passionate about anything and everything to do with the outdoors including camping, hunting, kayaking, and fly fishing. Vicki joined the Desert Foothills Land Trust staff in December 2011 as the Conservation Director where she manages all land acquisition projects and stewards the nearly 1,000 acres permanently protected by the Land Trust. In late 2016, she additionally assumed the role as President & CEO and is proud to be a part of such an amazing group of dedicated members, volunteers, stewards, and supporters.

## **Brian Butler, Chair**

For over 40 years, Brian Butler has represented clients in litigation. He has conducted jury trials, court trials, preliminary injunction hearings, arbitrations, and appeals in state and federal courts.
